GREAT RESULT FOR TRACKS ANNOUNCED



Affiliated venues are due to receive public liability scheme renewal invitations from Marsh Advantage today, and it's pleasing to be able to report there is **no increase in meeting permit pricing** from last year. Mark Holmes and the team have delivered another great result, which means that Speedway Australia tracks are continuing to pay less than they used to, for an ever-increasing array of benefits and services.

For example, a AAA meeting permit is still 39% lower than 8 years ago, and that's before the impact of Speedway Australia's \$100,000 grant scheme that tracks were advised about earlier this week.

Just a reminder that the meeting permit fees include the following benefits:-

- **FREE Practices (as many as there are race meetings over the course of the year)**
- **A low \$1,500 excess**
- **\$50,000,000 of public liability cover for every minute of the year**
- **For a two day meeting the permit fee is only 50% for the second day**
- **Complimentary affiliation to Speedway Australia and access to our services and benefits (grant schemes, grant application assistance, annual awards, national forums, Speedway Sedans Australia national title eligibility, World Series Sprintcars, iRacing events, officials training, rulebook, and more!)**
