OFFICIALS UNDER 40 – APPLY NOW!



Applications are now open for the 2019/20 Speedway Australia Rising Star Officials Program

The Officials Rising Star Program will take place in conjunction with the highest-pressure road trip in Australian speedway – World Series Sprintcars Speedweek!

Starting in Murray Bridge on Boxing Night, four selected Rising Stars will be involved in a variety of experiences and learning situations. During the week each individual will buddy up with a

different administrator each night, rotating around the roles to ensure a full immersion. Those roles include the Chief Steward, WSS Race Director and Assistant Race Director, WSS Race Secretary, Social Media Co-ordinator and more. The four successful candidates will receive flights to and from Adelaide and Warrnambool, and accommodation from Dec 26 to January 2, with all other expenses covered – even their uniform.

We want to hear from Speedway Australia officials who are willing to come on the road during Speedweek and meet the following criteria: -

- A Speedway Australia licenced official as at 31 August 2019
- Under the age of 40 (in keeping with the Rising Star philosophy of developing young talent)
- Have a direction and desire to achieve within the sport
- Show a history of involvement with tracks or divisions
- Be able to endure the physical and mental strain of Speedweek, with long days and constant travel
- Have a driver's licence (to share the rental car driving duties)

We will be reaching out to all Licenced Officials under the age of 40 in the coming weeks with an invitation to apply for the Rising Stars Program. If your club knows of someone who meets the above criteria, but isn't currently a Speedway Australia Licenced Official, we insist you encourage them to become an official now for the chance to be involved in the officiating experience of a lifetime!

Applications can be made online, using the form via the link below. In addition to the personal details, applicants are also required to submit a brief presentation outlining their achievements and goals off track within the sport.

GET YOUR TRACK GRANT APPLICATION IN NOW



A fortnight ago we launched the latest Track Grant Scheme, setting aside \$50,000 for immediate improvements at Speedway Australia venues with a focus on safety, in particular items that can lead to a reduction in public liability claims.

The response has been overwhelming, with many venues having made submissions for items including smaller mesh for safety fences, improving the structure and strength of pit gates, and improvements to catch fences and wire ropes.

Track & Safety Development Officer, Liz Weaver is in the process of getting in touch with venues we think could benefit from this scheme, particularly those with issues around flying clay. However, all venues are also encouraged to apply if they have a desire to upgrade their facility in terms of the criteria above.

The application process is simple. An email or letter outlining what upgrades you wish to undertake at your venue and the benefit it will bring, together with quotes for materials to undertake the work, bearing in mind we will not fund the labour portion of any upgrade. There are no guarantees as \$50,000 is a drop in the bucket of what could be spent on venue upgrades, but it is a start and we fully intend to derive maximum benefit from it – so make your application count!

We can approve a maximum of \$10,000 to any one venue, but it's more likely that grants will be in the region of \$3000 - \$5000.

For venues which may require upgrades over and above what we can afford, we strongly suggest you get in touch with your relevant Sport Development Officer who can help you apply for external funding through various State and Federal Government Programs. If you're in QLD, NSW or VIC your contact is Adam Brook, while in WA, SA, NT and TAS it's Ross Kirby who can be of assistance.
